13 Pursuant to LR 7-1, Plaintiff North American Derivatives Exchange (CDNA)
14 and Defendants Mike Dreitzer, George Assad, Chandeni K. Sendall, in their official
15 capacities, the Nevada Gaming Control Board, and Aaron D. Ford, Attorney General
16 of Nevada (State Defendants) hereby provide the following notice.

17 1. On October 14, 2025, the Court entered an order denying CDNA's motion
18 for a preliminary injunction to prevent enforcement of the Nevada gaming laws with
19 respect to event contracts listed on CDNA's designated contract market (DCM) (the
20 Order). *See* ECF No. 45.

21 2. CDNA intends to appeal the Order to the Ninth Circuit.

22 3. Pursuant to the Court's direction at the October 2, 2025, hearing, the
23 parties have conferred about the need for interim relief regarding enforcement
24 pending appeal.

25 4. The parties have reached an agreement that obviates the need for
26 interim relief regarding enforcement pending appeal, and accordingly no such relief
27 is or will be requested.

28 5. This notice is without prejudice to any claims, rights, or defenses of any
party.

6. Intervenor-Defendant Nevada Resort Association has been consulted
about the agreement between CDNA and the State Defendants and has no objection.
